Alana Cadogan, Chief Executive Officer



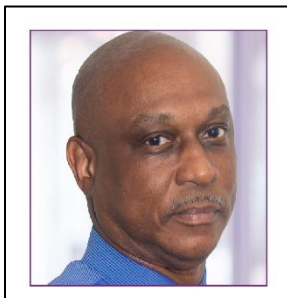

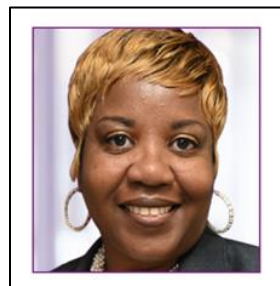
